## AN ORDINANCE ADJUSTING THE GARBAGE COLLECTION FEE TO REFLECT THE ACTUAL COST OF COLLECTION

WHEREAS, ten (10) asterisks separated by a single space indicate that unchanged text precedes the amended text, words in strike through type are deletions from existing law, and words <u>underscored</u> are additions.

WHEREAS, the cost of collection and disposal of garbage is not now adequately covered under the present user charges structure; and,

WHEREAS, appropriate budgetary and rate structures have been defined in a detailed analysis of the existing system by the Finance Department; and

WHEREAS, the budgetary structure established by the recommended rate system will allow the City of Kenner to maintain its level of service and to upgrade existing services and facilities as necessary.

THE COUNCIL FOR THE CITY OF KENNER HEREBY ORDAINS:

SECTION ONE: Sec. 9½-5 (a) and (f) of the Kenner Code of Ordinances is amended as follows:

Sec. 9½-5. - Changes for the collection and disposal of refuse.

- (a) The fees <u>charged to Residential Units and Small Business Units</u> for collection and disposal of refuse which is placed between the sidewalk and curb shall be <u>equal to</u> the actual cost of collection that the City of Kenner incurs for the collection and disposal of the refuse. This charge shall be a monthly charge. The Administration is authorized to devise the formula used to calculate the monthly charge to each Residential Unit and Small Business Unit. three dollars and five cents (\$3.05) per month per dwelling unit in the City of Kenner and six dollars and fifteen cents (\$6.15) per month per business location utilizing the City of Kenner's garbage service.
- (f) Recycling. That the mayor is hereby authorized to amend the current garbage collection fee to include a curbside recycling fee of one dollar and fifty cents (\$1.50) per dwelling unit for the purpose of defraying the cost of the city-wide curbside recycling program. This combined fee will be known as the solid waste collection fee.

- (1) This solid waste collection fee will be subject to an annual adjustment, not to exceed the annual charge, in accordance with the contract Consumer Price Index (CPI) clause.
- (2) That heads of households 65 years and older only may apply for a fifty (50) percent reduction in the Solid Waste Recycling Fee in accordance with established requirements.

AN ORDINANCE AUTHORIZING AN ASSESSMENT OF A RECYCLING FEE

WHEREAS, ten (10) asterisks separated by a single space indicate that unchanged text precedes the amended text, words in strike through type are deletions from existing law, and words <u>underscored</u> are additions.

WHEREAS, the Kenner City Council had authorized the assessment of a recycling fee; and,

WHEREAS, as a result of Hurricane Katrina curbside recycling ceased in the City of Kenner for a number of years; and,

WHEREAS, curbside recycling has since returned to the City of Kenner, but the fee initially authorized for curbside recycling either is not being collected; and,

WHEREAS, in order to maintain curbside recycling it is necessary to charge \$2.52 per month per residential unit.

THE COUNCIL FOR THE CITY OF KENNER HEREBY ORDAINS:

SECTION ONE: Sec. 9½-5(f) of the Kenner Code of Ordinances is amended as follows:

Sec. 9½-5. - Changes for the collection and disposal of refuse.

(f) Recycling. That the mayor is hereby authorized to amend the current garbage collection fee to include a curbside recycling fee of <u>two dollar and fifty-two cents</u> one dollar and fifty cents (\$2.52 \$1.50) per dwelling unit for the purpose of defraying the cost of the city-wide curbside recycling program. This combined fee will be known as the solid waste collection fee.

- (1) This solid waste collection fee will be subject to an annual adjustment, not to exceed the annual charge, in accordance with the contract Consumer Price Index (CPI) clause.
- (2) That heads of households 65 years and older only may apply for a fifty (50) percent reduction in the Solid Waste Recycling Fee in accordance with established requirements.
