Considering the foregoing Verified Petition for TRO, Injunctive Relief, and Damages submitted by plaintiff, Ramelli Janitorial Service, Inc.;

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that defendant, IV Waste, LLC, be and is hereby enjoined, restrained, and prohibited from using, accessing, or interfering with any and all Ramelli owned roll-out carts, dumpsters, or other garbage containers.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Plaintiff's request for preliminary injunction be and is hereby set for hearing on the 21st day of May, 2020 at 10 o'clock a.m.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the preliminary injunction shall be heard upon the verified pleadings and supporting affidavits as permitted by La. Code Civ. Proc. art. 3609. Plaintiff shall deliver copies of its supporting affidavits to the defendants at least twenty-four hours before the hearing. The Defendants shall deliver copies of their affidavits prior to the hearing.
